		- 1 - DECLARATION OF MONA GANDHI

I, Mona Gandhi, declare as follows:

- 1. I am one of the named plaintiffs and class representatives in the above-captioned case. I submit this declaration in support of Plaintiffs' motion for final approval of class action settlement and in support of the request for service awards. The facts set forth herein are true and based on my own personal knowledge, except where based upon a review of the relevant pleadings and records. I have personal knowledge of the facts set forth herein, and if called to testify thereto, I could and would do so competently.
- 2. In January 2013, having seen representations for a Net10 "unlimited" mobile phone plan, and based primarily on the promise of the plan including "unlimited" data, I purchased a Net10 SIM card from a local wireless phone dealer and signed up for a Net10 "unlimited" data plan. I was later surprised to find my data service terminated. I called customer service to complain, and was transferred to a "High Data Usage Hotline" recorded message. Based on my experience I decided to file a lawsuit against Defendants and agreed to be a class representative in this case, undertaking the burdens and risks associated with litigation, to help put a stop to what I believed were Defendants' wrongful and deceptive practices.
- 3. Pursuant to my duties as a plaintiff and class representative, I have been actively engaged in this case. Among other things, I have provided information to my attorneys about my experience, reviewed the allegations in the complaint, and consulted with Class Counsel multiple times during the course of the case, staying updated about the status of the case and the settlement negotiations. In all, although I have not maintained records of the time spent participating in this case, I estimate that I spent approximately 9 hours working on this case.
- 4. I reviewed the settlement agreement and discussed the settlement agreement terms with Class Counsel. Based on my personal experience regarding my purchase of a Net10 "unlimited" service plan and subsequent data termination, and on my involvement in this lawsuit,

1 I believe that the settlement is fair, reasonable, adequate and in the best interests of the respective 2 class members. 3 5.
